**NOTICE OF START OF CONSTRUCTION**

Loeser, Traweek, Lone Star, West Tex, and Lariat  
Pavement and Utility Improvement Project

In March, you should have received a letter from the City concerning the selection of Conrad Construction Company, Inc. ("Conrad Construction") to reconstruct Loeser, Traweek, Lone Star, West Tex, and Lariat and the delay in the start of construction of the project due to supply disruptions caused by COVID-19. The City and Conrad Construction both anticipated that Conrad Construction would be able to proceed with mobilizing equipment and beginning some preliminary work while supply began to return to some normalcy. However, this was not the case. Supply disruptions have continued through April but have begun to resolve themselves.

The City will be issuing a **Construction Notice to Proceed on May 10, 2021**, and Conrad Construction plans to start mobilization and performing preliminary work the week of May 10, 2021. Such activities may include moving in equipment, tree protection, survey, utility locates, and clearing of landscaping in the right-of-way. You should have received a letter from the City in December of 2020 that explained landscaping affected by construction activity in the City right-of-way.

With the start of the construction process, Conrad Construction will have equipment on-site and in the street, and equipment and materials will be stored at the end of Traweek and Lariat. As the project proceeds, there will be lane closures to install underground utilities and pavement reconstruction that will continue until the completion of the project. You will be notified of lane closures ahead of time by Conrad Construction.

In addition to communications from the City, Conrad Construction will utilize door tags and face-to-face communication with residents during the project. A copy of the door tag from Conrad Construction is provided with this letter. Please be sure to check your front door regularly for these door tags.

The City and Conrad Construction will continue to update you with construction information as appropriate. Construction Updates will also be available through the City's new [mobile app](#) and on the [Public Works Page](#) of the City's website.

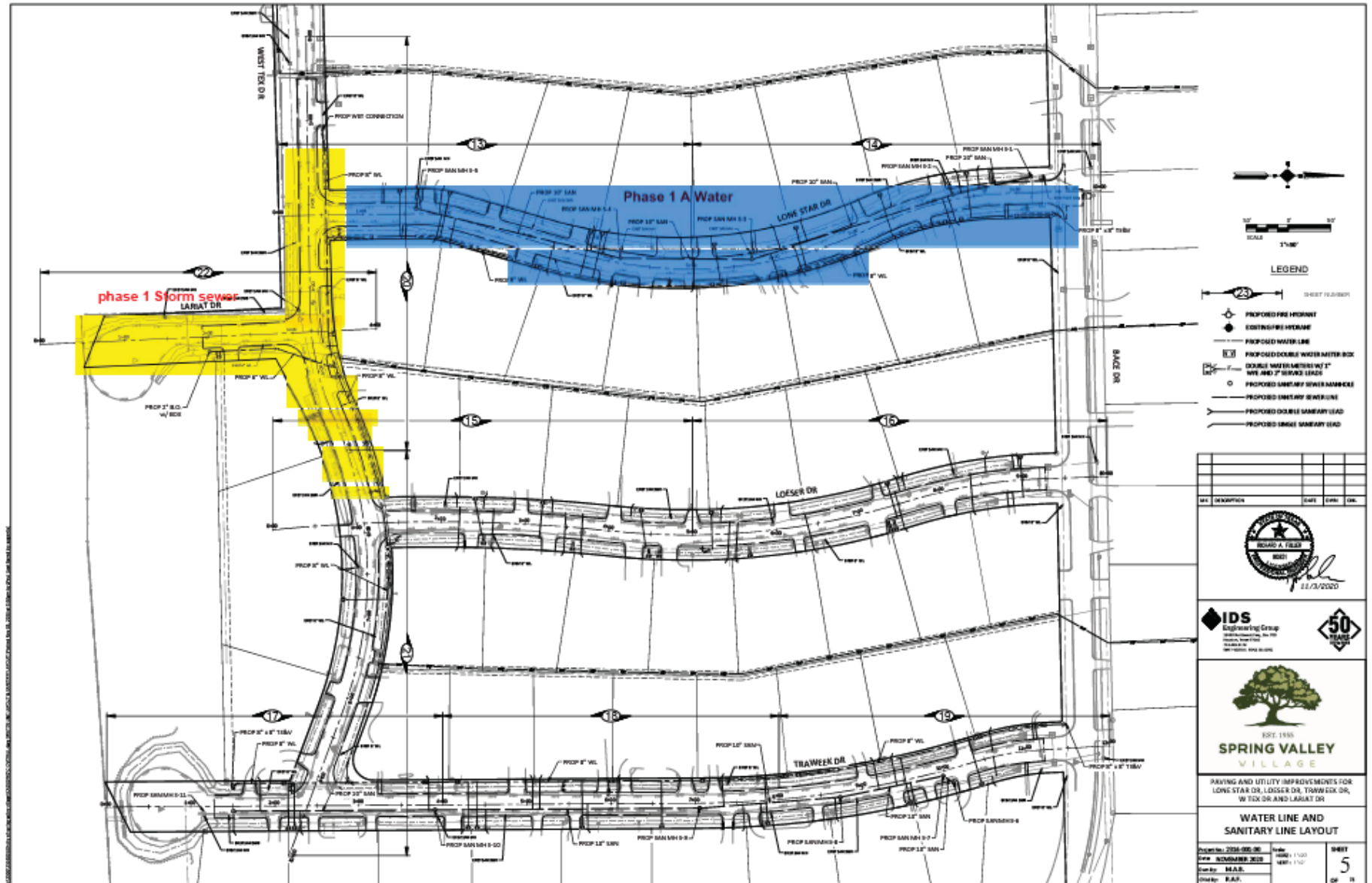

## Proposed Construction Phasing Map

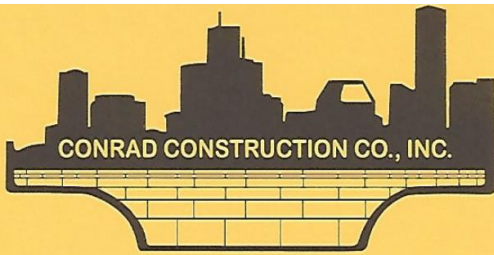
